SUPPLY PASTORS COMPENSATION

Compensation to visiting pastors is the responsibility of the host congregation.

Congregations should consider the following to be a guideline in compensating supply pastors:

- One Service of Worship \$200
- Two Services of Worship (same day) \$250
- Preparing for and Teaching Bible Class/Adult Forum \$ 100

In addition, mileage should be reimbursed at the current IRS rate. At the time the IRS established the Mileage Rate at 55.5 cents.

Supply pastors should be paid on the day they provide the service.

Example: A supply pastor serving at a Saturday evening worship service and two Sunday morning worship services should receive \$200 + \$250 = \$450 + travel
