

We hosted a brainstorming luncheon where members were invited to share their ideas, and there will be a follow up meeting to discuss the steps to put our ideas into action. The Rev. Marsha Harris Central, Van Nuys Rostered Woman

Congregational service, currently and within the last three years:

First, I serve as Pastor and Administrator in a bilingual congregation that has been increasing its commitment to its deeply impoverished neighboring community. I have led them to create a sense of vision and mission that was missing prior to my arrival



part-time in 2016, and as called Pastor in 2017. One of the earlier things we were led to do was reconsider our impact on the neighborhood, and on the world around us. As for the world, a key piece is creation care: we now are solarized for our electricity, we strive to use compostables and renewable products whenever possible, including bamboo and recycled papers in most applications.

We planted 7 fruit trees around our parking lot in 2017-18, to both provide cooling for the asphalt impact and to offer fruit for gleaning to our neighbors, both unhoused and housed. We began food distribution in 2019, and shortly after the pandemic began and other food distribution and pantries closed we moved our service to weekly, now serving between 350-400+ households each week, between 1350 to 1850 persons. Prior to the pandemic we were offering weekly English classes to help our neighbors find better jobs and help their children with homework.

Through both my work and that of leaders we have raised up and others we have invited into serve with us, we have expanded our connections and increased our ability to bring resources into the community for the sake of food security, and addressing some root causes of poverty and homelessness. We now have a Garden Advisory Committee for the 1/2 acre Community Garden that hosts 30 individual gardener families and offers classes to the wider community. We also have an Advisory Committee of young 40's adults who have been drawn to serve their neighbors and are finding their way toward faith even as they help us plan for ways to better serve our neighbors, recruit volunteers and increase our ability to sustain these ministries.

Central has served as a host for homeless services for almost 19 years, and while there is no longer a drop-in service here, the Access Center and showers on our site still bring persons experiencing homelessness to our door and to our worship regularly.

Further, in 2021 we reopened our Camp @ Central (aft/evening camp) to serve 19 elementary aged children with the help of LRCC, 4 area youth and a team of volunteers that included a homeless couple whose children were in our camp. We currently host a TEEM candidate who is also completing her Bachelors degree at Cal Lutheran University. Central's current tagline is: Loving our Neighbor, Caring for Creation, Promoting Food Security, and meeting people wherever they are in faith to grow

Community Service, currently and within the past three years:

I have served with the LAPD Clergy Council since I was serving part-time, and upon my call and ordination in 2017, have continued as a regular partner and contributor. This has offered me connections for prayer caravans with other clergy and laity in the Van Nuys area, as well as new connections with local decision-makers, and with the local media.

Central identifies over 50 community organizations with whom we have partnered in recent years to promote their programs and ours including the Valley Pres Hospital, MEND, Helpful Honda, Tierra del Sol, Partners for Potential, and AAIMM (African American Infant and Mother Mortality) Task Force of LA Co Dept of Health. I have personally developed these relationships and have empowered others to either maintain them or to revisit them as we have moved to address the needs of our community.

I have served since 2019-20 with the Twin Valleys Conference Confirmation program, helping to teach, lead ice-breakers and discuss ways to grow our children in faith. I was one of the organizers of the Twin Valleys Conference initiative to develop better collaboration. In 2018, when our Conference voted for the study I was elected to co-preside over the efforts, and to co-supervise the consultant. When the organization was ready to form an Interim Board in 2019, I was elected chair, and have served as the Chair as we halted then restarted our collaboration efforts through the pandemic. I was blessed to see

the Twin Valleys Lutheran Parish officially launched at a Worship and Conference Assembly in September 2021, and to celebrate the granting of its 501(c)3 Non-Profit status after 10 months of waiting on the IRS, and I will be turning over the role of Board Chair when my term expires in fall 2022.

I will continue to serve in 2022-23 as the lead of the Ministry Table and liaison to the Board for the Twin Valleys Lutheran Parish "Synodical Congregational Sustainability Initiative" known as LatinX Ministry Strategy. This work is set to launch this summer to train - in collaboration with Rev. Dr. Alexia Salvatierra and Rev. Dr Michael Mata - 4-8 Spanish speaking faith leaders in active Bible study that will seek ways to respond to the gospel in their lives through serving their communities, as the Holy Spirit leads their groups. This work will be done with persons not necessarily connected to existing congregations, and will involve the work of prayer of the congregations they are linked with, to see the work through to fruit within 18 months to 2 years of its start.

In 2021 I completed the training for LA County Master Gardener, as part of my Continuing Education for Creation Care during the pandemic. I am allowed to serve Central's community garden for 1/2 of my servicer hours, and am required to serve other projects for the other half. I serve on the Diversity, Equity and Inclusion Task force for the LA County Master Gardeners. This also links me with 400+ Master Gardeners serving all over LA County, in a variety of contexts and climates, enriching my should even as I teach others.

Synod involvement, currently and within the past three years:

I have served since 2015 (my internship with New City Parish & St. Marks-LA) with the Synod Green Faith Team. During recent years I have helped plan greater inclusion of Spanish Speakers in the World Water Day events, and have brought an urban ministry perspective to the table in discussions about how congregations can be both green and solvent.

I have also served since 2015 with the Evangelical Outreach Mission Table, including a) evaluating new start and redevelopment ministries for their annual review and funding recommendations, b) reviewing properties to make recommendations from EOMT for future mission potential or sale so as to fund such future missions, c) evaluating holy innovation proposals (2018) for funding through special innovations monies Synod Council had set aside, d) emergency

aid grants to congregations stepping up to serve in new ways during the pandemic, and needing new technology assistance funds for worship or other community outreach. As such,

I have been on the side of "applicant while on the committee", and am fully aware and experienced with stepping away from discussion and recommendations on any project I am party to, as part of the Synod's Conflict of Interest Policy. I even know how to do it on Zoom, and still get called back to the meeting when we're moving on to others' projects!

The Twin Valleys Lutheran Parish and its process to come into collaborative ministries has also drawn me more deeply into a variety of Synod activities, including: 1) asking questions about what is our mission, 2) seeking where we can find and sustain funding, 3) how do we reward initiative even if success is not always a certainty, and 4) what is the relationship between ELCA Church-Wide, our Synod, the Conferences, and a Parish.

Pasadena, with waitstaff, entertainment, and a 3 course meal served around banquet tables. I ecumenically partnered with Fellowship Church to organize, cook, and serve these banquets. In 2021 I founded the Trinity Safe Parking Program, which provides overnight parking for individuals living in a vehicle, with access to bathrooms and electricity, showers, and case management to find housing and services. I partnered with Foothill Unity Center for case management and security services, and with San Gabriel Valley Safe Parking Committee for organizational structure.

Community Service, currently and within the past three years:

In addition to the Trinity Safe Parking, the Trinity Food Ministry, and the Trinity Great Banquets, I have been a board member with Lutheran Social Services of Southern California since 2019, serving on their Mission Advancement Committee.






