# Director for Evangelical Mission (DEM) The Rev. Chryll D. Crews, M.Div, J.D.

This report includes former DEM, Rev. Dr. Marjorie Funk-Pihl's, report from June-August 2021. There was not an official DEM from September 2021-October 31, 2021. I began as DEM on November 1, 2021. Therefore, my administration began with Mission Development Reviews spearheaded by Pastor Toni Joseph and EOMT. Attached to this report is the most current EOMT report submitted to the Synod Council on November 20, 2021. I conclude the report with some specific assignments related to my role as Assistant to the Bishop.

**From Rev. Dr. Marjorie Funk-Pihl:** Peace/Paz Lompoc finished their neighborhood study and I started the application for them to become a parallel development. I also got a Strategic Ministry grant for St John's, Gardena. We tried to move Another Level to Gardena with Pr. Maurice - but that fell through. We did move Redimidos to Our Saviour's in Oxnard.

Glory Lutheran Church (Chinese) became a recognized congregation of the ELCA...we all worked very hard to see this happen! They had to translate the constitution into Mandarin and walk the congregation through it - to vote on all the "this or that" clauses. There are 10 votes that have to be taken to become a congregation - and we did it!

From Rev. Chryll D. Crews: A Review Table was held to determine if the Church Wide Office (CWO) would accept EOMT's grant recommendations. All requests were granted except the following: ADORE LA's request was \$26,000 but they received \$24,000. Fruit of The Spirit received \$18,000, not the \$20,000 requested. Fruit of The Spirit, however, was able to find funding from partner donors to make up for the difference plus a little extra. Documentation and recommendations are based on EOMT's recommendations, the Annual Reviews held in November 2021, and the OEM's recommendations.

I also conducted and submitted Mission Developer Reviews to the CWO. I also was responsible for the distribution of the grants by submitting the Authorization for Payment Forms for all SAWCs and our Strategic Ministries. Another

prerequisite that must be completed before grants are distributed is the SAWC and Strategic Ministry Covenants. These covenants must be signed by the Mission Developer and a lay officer of the ministry. I oversaw these requirements and submitted all forms to the CWO.

I worked with Pastora Jade Ortiz in completing her paperwork making the Synod her new Fiscal Agent.

I continue to support Bishop Bos with any advisement she seeks and I look forward to our weekly individual meetings and our pastoral staff meetings, where we discuss the future of all our congregations. It's been six months and my responsibilities are varied enough to keep me busy and engaged.

The leaders of the EOMT have had another successful year of supporting New Starts, Parallel Developments, Strategic Ministry, Synod Vitality Strategies, Specialized Ministry, and innovative emerging ministry of the synod. Great thanks and appreciation are owed to Valerie Shaw, Pastor Maria Paiva, Pastor Marsha Harris and Synod Council members Zekiah Wright, Todd Kolberg, Nolan Green, and Laura Salazar, as well as Executive Staff members Rev. Chryll Crews and Rev. Joseph Toni Castaneda Carrera.

#### **Background and Information**

- The leaders of EOMT conducted annual reviews of three New Start Synod-Authorized Worshipping Communities (SAWCs), four Parallel Development SAWCs, and four Strategic Ministries. All reviewed grantees were assessed as positive investments and recommended for continued funding.
- The EOMT anticipates expending \$82,000 from FLAFF based upon expectation of investment performance over the last year.
- The Strategic Ministries Grant recommendations are to execute with proceeds from the sale of the North Hollywood Property, using the one-time formula recorded in synod minutes SC2I .04.04.
- EOMT leaders recommend funding for a new Latinx Ministry Parallel Development SAWC to partner with Peace Lutheran in Lompoc as a legacy congregation.

#### **2022 FLAFF Grant Recommendations**

- EOMT recommend granting \$82,000 to New Start SAWCs and Parallel Development SAWCs for 2022.
- EOMT also recommends a request of \$141,000 matching funds from the Churchwide Organization.
