-----Synod Vice-President-----

The Synod Vice President position must be filled by a layperson. As chairperson of the synod council and executive committee, the vice president is expected to be present at all meetings and to report the actions of the Synod Council to the Synod Assembly. The term of office is 3 years with one reelection. The vice president will need a vision of the mission of the church, a record of leadership in their local congregation, and a commitment to Christ expressed in the stewardship of one's gifts. They must be able to share openly in the decisions concerning the policies and mission of the church, and be ready to assist the bishop of the synod in working with the agencies, institutions, conferences, and congregations in implementing the work of the synod. The Synod Vice President serves as the principal lay leader of the synod.

#### **Consultation Committee (1)**

Term: 6 years Lay Person

The primary responsibility will be to hear the issues of all parties involved in cases related to ordained ministers, officers, congregations, and members of congregations and recommend whether or not disciplinary action should be taken. It will consist of at least six persons and not more than twelve persons, of whom half shall be ordained ministers and half shall be lay persons, who shall be elected by the Synod Assembly. This position is a voluntary one and will meet on an "as needed" basis. Each person must be a voting member of an ELCA congregation. Persons serving on the Consultation Committee must have an ability to listen to the opinions of many persons and process them into a recommendation, which will be fair to all parties involved. They must be able to share openly in discussions of very sensitive matters and must know the policy and mission of the church and be willing to uphold the integrity of the church and individuals to which the church ministers.

#### **Discipline Committee (1)**

It will consist of twelve persons, of whom half shall be ordained ministers and half shall be lay persons, who shall be elected by the Synod Assembly. This position is a voluntary one and will meet on an "as needed" basis. Each person must be a voting member of an ELCA congregation. Persons serving on the Discipline Committee must have an ability to process input from many persons in reaching a consensus of opinion. Persons must be able to share openly in discussions of very sensitive matters. Persons serving on the Discipline Committee must know the policy and mission of the church. They must be compassionate with a commitment to fairness and justice.
